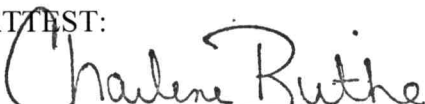
Commissioner Patrick Wiesner moved to adjourn the meeting, Seconded by Commissioner Ken Williams.

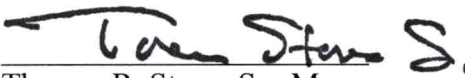
