Ordinance #926 -Working Cash Ord.

Commissioner Collins moved that Ordinance #927, levying taxes for all corporate purposes of the City of Oregon for the fiscal year May 1, 1986 and ending April 30, 1987 be passed.

A discussion followed the motion. A citizen questioned the levy for Illinois Municipal Retirement Fund, expressing his opinion that the fund balance was high enough and a tax should not be levied. The Council agreed to eliminate the levy.
