The current Ephedrine Ordinance requires any drug containing 30 mg of ephedrine should be behind the counter of any businesses in the city limits. The modified ordinance would require any drug over 60 mg needs to be moved behind the counter. Commissioner Nick Johnson moved to modify Ordinance No. 1190 -Sale of Ephedrine, Seconded by Commissioner Jim Tegtmeyer.

Dr. Champley a veterinary at Pines meadow spoke regarding putting a limit on how many pets a household would be allowed. He is not in favor of putting on a limit of pets. He said the Ogle County Animal Control is considering mandatory micro chipping dogs residing in the county. He said with a microchip, dogs that are running at large could be identified back to their owner. This won't be ideal but it should take care of the stray dog situation, stated Champley.

Tim Krug also spoke against putting a limit on how many pets a household would be allowed. His household right now has four dogs. One of their dogs was from an animal shelter. It would have been put to sleep if they would not have taken the dog. He feels that if we have a few bad eggs in town don't punish everyone.

The council discussed the proposed ordinances on limiting the amount of pets, fence requirements for swimming pools, and parking fines. These issues were tabled for more research.

Commissioner Nick Johnson moved to approve the special-use permit submitted by Riverwest Development to "y" the sewer connections on Lot 13, 16, 17, & 18 in Century Hills Subdivision for townhouses, Seconded by Commissioner Jim Tegtmeyer.

Commissioner Jim Tegtmeyer announced that Mike Bowers was having nine trees tested by the Extension Office to see if they do have verticillium wilt. The test results should be back before the next council meeting.

Commissioner Bob Rees announced that he and Mike Bowers have been working on specifications for bidding the job to replace the coliseum roof. He also handed out a sludge evaluation done by CMT. This evaluation will help plan for the future of the Water and Sewer Department.

Mayor Tom Stone announced that he attended his first Northern Illinois Mayor meeting. The Oregon Fire Department applied for a one day liquor license for October 3rd. The liquor commission approved this license.
