Bernie Klingenberg of Willett, Hofmann & Associates, gave an update on several city projects.

Mayor Barnes advised he would like to have an ordinance drawn up controlling garage sales. He would like to see only 3 garage sales in a 12 month period and limit the duration of the sale to three days. Also to have the garage sale signs removed immediately after the sale from the poles. Attorney Smith will draw up the ordinance.

Mayor Barnes asked the Council for approval to have a display case made for the vestibule at City Hall. The Council agreed.

Marine Kuethe addressed the Council with complaints over the rust in the water and the foul smell of the water. Roger Warrenfeltz will be instructed to check the water for odor and to flush hydrants to try to eliminate the rust.
