Corky Wetzel from NICOR gave a brief presentation on renewing the gas ordinance. It has expired three years ago and the current agreement was for 40 years. The new agreement would be for 50 years. The Council members and City Attorney will look over the ordinance and discuss it at a future meeting.

Commissioner Amy Trimble announced that Blackhawk Water Ways & Convention and Visitor Bureau has received a grant on tourism and that they will video Oregon during the Autumn on Parade weekend. The six to seven minute video will be shown on the Discovery Channel in December.

Commissioner Tom Stone moved to accept the proper low bid for Street Maintenance to Brandt Construction in the amount of \$34,431.85 to be paid from Motor Fuel Tax funds, Seconded by Commissioner Amy Trimble.

Beth Thacker discussed changing the welcome to Oregon signs. Currently the old sign has the different service organizations attached. Project Oregon, Oregon Preservation Commission, and the Chamber Members are working on drawing up a proposal to the City Council.
