DeBruyne then addressed the outstanding fees for each project. He stated that he had discussed the additional amount with then Commissioner Lauer and had assurance that Commissioner Lauer would take it to the Council. The additional fees are \$25,000.00 over the contract price for the Wastewater Treatment Plant and \$21,500.00 over the contract price for the Facilities Plan project. He stated that the additions came from changes required by the IEPA and requested by Roger Warrenfeltz. Mayor Barnes expressed his concern as to why they would go ahead with the additions without council approval. The Council will make a decision on the invoicing by the next council meeting.

Mayor Barnes asked that the Clerk write a letter to the Autumn on Parade committee and advise them that the City will do as they have in the past to assist the committee.
