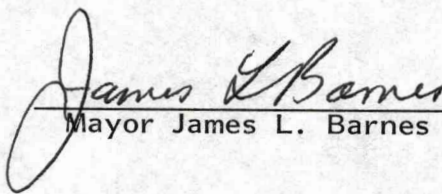

Seconded by Jim Lauer.

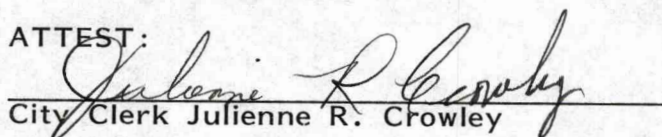
