The Council agreed to have a special meeting on September 19, 1994 at 5:00 P.M. to award the contract.

The Autumn on Parade committee submitted a request for City assistance for the weekend of October 1st and 2nd. The assistance is the same as it was last year. The Council approved the request.

Commissioner Svoboda asked the Council if the City should give away the rust remover to customers. The Council said no.

Commissioner Svoboda advised that the Fifth Street project is completed and E.P.A. approved.

Commissioner Priller advised that the street department now has an asphalt hauling tank, thanks to E. D. Etnyre Company for supplying the parts and the street department for putting it together. They now have a \$13,000.00 piece of equipment for about \$3,000.00.

Commissioner Aurand asked the Council if it wouldn't be wise to get a consultant to go over our water system and at the end of the six month chlorination period, they might furnish the City a letter that says that our system is up to date. Aurand feels that might lend more credibility to the E.P.A. when the City refiles for an exemption. Mayor Barnes agreed that is something that the City should explore. Bernie Klingenberg will look into getting a consultant.

Mr. Bergschmidt complained about the traffic at First & Gale Streets. Chief Miller will look into it.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by John Priller.
