The Council of the City of Oregon met in regular session Monday, August 23, 1982 at 7:00 P.M., City Hall Building.

Present: James Barnes, Mayor and Commissioners Robert Aurand, Frank Svoboda, James Ludwig and Norman Collins. Absent: None.

Also present: City Attorney David Smith and City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Collins moved that the minutes of the August 9, 1982 meeting be approved as recorded. Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that the application for a Class A Liquor License submitted by Jan and Marla Freil, D/B/A Jam,

A license to be issued upon receipt of the required bond, proof of Corporate status, the fee of \$100.00 for September 1 through October 31, 1982 and the forfeiture of the license held by Richard and Iris Haye, D/B/A Ganymede, for the location of 412 Washington Street. The term of the license to be from September 1, 1982 through April 30, 1983. Seconded by Robert Aurand.

Commissioner Svoboda moved that the Hughes Subdivision Plat be approved as recommended by the Plan Commission. Seconded by Robert Aurand.

Mayor Barnes proclaimed September 6, Monday, as Jerry Lewis Telethon Day for the Muscular Dystrophy Association.

Dennis McMullen, representative for McClure Engineering, advised the Council he had received a report from Hanson Engineers, in regard to the cores taken on Fourteenth Street in Wright Subdivision. He advised that the report shows apparent failures in the road surface. The Council instructed McMullen to contact Larry Wright and the certifying engineer, Willett and Hoffman and Associates of the failed areas and request that the road be restored to the proper condition required by the City Ordinances.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by Frank Svoboda.
