Commissioner Jim Tegtmeyer and Mike Bowers met with David Bruckner a Certified Arborist to determine what the Oldest Tree in town died from. In his opinion the tree has been killed by the two-lined chestnut borer and not oak wilt. The adult two-lined chestnut borers primarily attack oaks that are damaged by drought or trees that are suppressed or declining. Prevention is the only way to help reduce the chances of this insect spreading to more oaks. Chemical control on trees closest to the dead tree can also help reduce the chances of this insect killing these trees, but it can take up to two years or more before the tree can die from this insect or show the D-shape exit holes. Chemical treatment is recommended in the spring. Jim asked if any residents in the north end that would be interested in the treatment should contact City Hall. More information on this can be picked up at City Hall.

Commissioner Jim Tegtmeyer addressed a letter to the editor from Kathy Wilson. She has concerns regarding the Washington Street project that will be from the bridge to Illinois Street. The streets will not be widened; only twenty two trees will be removed for widening the corners, a traffic light will be put in at 10th Street, and Mix Street will be closed to Washington Street. Weekly updates will be on the website and in the newspaper.

Commissioner Jim Tegtmeyer fells that the Plan Commission should not run a public meeting for the Route 2 project. He would like to organize and run the meeting. At this point in time the city council has not met with IDOT since the meeting regarding the round about and they are waiting for the structural engineer report on the two building at Route 2 & 64. The council agreed that the city did
