Commissioner Lauer moved to advertise for bids to purchase a dump box and plow for a street department truck. Bids to be opened at 12 Noon, September 11, 1987 at City Hall. Seconded by Norman Collins.

Tom Ballard addressed the Council requesting stop signs to be put at the corner of Sixth & Franklin Streets. He feels this is a dangerous intersection and would like to see 4-way stop signs there. Commissioner Lauer advised he would check the area with Chief Miller.

The Council briefly discussed the bicycle ordinance which was introduced June 22, 1987.

Commissioner Crenshaw asked if there was an appraisal of the work which needs to be done at the Coliseum. Such as wiring, heating and acoustics. There are no appraisals at this time. She is going to check into the Civic Center Authority to see if funds are available to up date the building. Mayor Barnes advised the boiler is all right but the old radiators and piping are bad. Mayor Barnes advised we could have the Coliseum Board get estimates on the needed improvements.

Commissioner Lauer advised he had received several responses from engineering firms. The Council agreed to have a special meeting to interview different firms and listen to their presentations.

Commissioner Logan brought to the Council's attention that the Sheriff's Department is going to move their garage location to the Dave Martin property on Route #64 West. That location is zoned R-1. A Special Use Permit will have to be obtained through the Plan Commission in order for the County to use the site for a garage. Dave Martin is to be advised by the Clerk of this situation.
