> East Oregon Water System-Hook-up Costs Waived.

Reports

The Council agreed to waive hook-up fees on the East Oregon Water System to all of those who hook up within 90 days after the system is accepted.

Enginner's Report:

1. Advised East Oregon Water System should be accepted by September 15th.

2. Advised that he would have a policy statement in regard to the existing wells for the residents who hook up to the water system. This would have to be made into an ordinance for the City Code Book. The regulations should be in compliance with the Department of Mines and Minerals regulations. If the property is put on the system, the well must be plugged and capped.

Commissioner Svoboda advised that Larry Wright had requested to hook up water at Fifth & Ford Streets for a new residence from the house next door, being a private line. The Council denied the request.

The merchants of Conover Square requested that the parking area in front of Conover Square be blocked off for Sidewalk Days. The Council granted the request.

The Council discussed the city doing the billing for the garbage. If this is done, the city would not have to bid. It could be a cost saving and the city would have control over the collections. Attorney Smith will pursue the possibility and obtain details necessary for the change.

Garbage Billing

Commissioner Svoboda requested permission to purchase two fire hydrants left from the East Oregon construction project. Permission granted.
