Melvin Kielsmeier requested a letter of approval from the Council be sent to Illinois Dept. of Transportation and Dept. of Conservation for the river bank improvements he has seeked permits for on his property at 123 N. Second Street. The Council agreed to supply letters of approval.

Commissioner Logan moved to authorize the engineer to submit a proposal to update the facility plan and to authorize himself to negotiate fees for for the plan update with the engineer. He further moved that the proposal be due by the next regular meeting. Seconded by Norman Collins.
