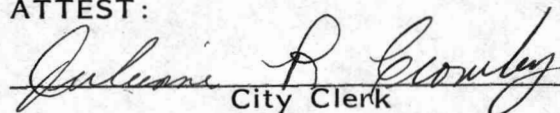
There being no further business, Commissioner Collins

Seconded by James Ludwig.

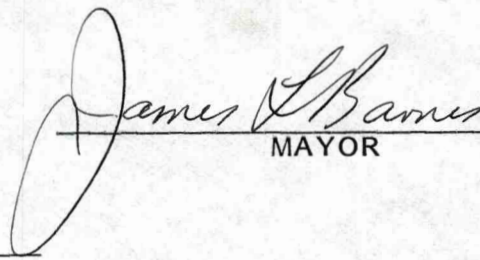
