Mayor Barnes proclaimed October 25th and October 26h Knights of Columbus Mentally Handicapped Days.

Mayor Barnes moved to approve the request of the Village of Woodridge to use our radio frequency 155.745, call sign KWS 469, using a maximum of 10 watts and a tower heighth of 25 feet, per attached letter. Seconded by John Priller.

State's Attorney Dennis Schumacher made a presentation to Chief Miller, a check in the amount of \$1,000.00, from a drug case in which Officer Whitsell participated in while on duty on June 15, 1991. The confiscated money was shared between the Ogle County Sheriff's Department, State's Attorney's office, Mt. Morris Police Department and Oregon Police Department.

Bill Fearer, III advised the Council he was interested in building a residence on Jackson Street west of Bonnen's where there is no city water or sewer lines at this time. He advised that he understood that the City was considering extending the water and sewer lines up Jackson Street but in the meantime he would like the opportunity to put an extension on from the lot area just west of Bonnen's to the existing sewer line and have permission from the City to connect to the existing water line. These connections would continue until the City extends the lines up Jackson Street, then he would connect to the City lines. Having permission at this time would allow him to go ahead and begin his building plans. The City Code does not allow any repair, altering or connecting to existing private water or sewer lines. The Council agreed to wait until Attorney Smith returns to see what the City can legally do.

Commissioner Svoboda advised the Council he had talked to Willett, Hofmann Engineers and they would draw up a sewer use ordinance for \$2,500.00 or less. The Council would like to get copies of other cities' ordinances before proceeding with this.

Commissioner Svobda advised he would like to have Willett, Hoffman engineers to do a water sewer rate study for the City. He was advised by Mayor Barnes that DCCA will do a study at no cost to the City. The Clerk will contact DCCA.

There being no further business, Commissioner Aurand moved that the meeting be adjourned. Seconded by Gerald Medlar.
