Commissioner Svoboda advised that the Fairground's water mains have had two positive tests and as far as the sewer is concerned, they will be televised next week. The lift station is not acceptable at this time. Civil Engineers is to be contacted by Attorney Smith and be given two weeks to complete the project.

Commissioner Priller moved to approve the expense of \$2,350.00 to Bonnell Industries to remove rust and paint the street department's 1977 Chevrolet truck, as outlined in their proposal. Seconded by Robert Aurand.

Commissioner Priller moved to accept the proposal by Myers Concrete for the construction of street and parking area in front of Conover Square of \$5,600.00.

Mrs. Howard Karper advised that she had talked to Frank Svoboda about her large water bill and Frank advised he would bring it up at the council meeting. Attorney Smith advised that the outside reader was defective and when it was replaced, the inside reader had registered correctly which caused that large usage to be shown. Attorney Smith advised her that the home owner is responsible for what water goes through the meter. Attorney Smith advised this was not a council problem. He feels that Commissioner Svoboda, City Clerk and Karpers can work out a payment schedule.

Mayor Barnes advised that a company is going to build on Pines Road and we would be advertising for bids for the water line.

Mayor Barnes advised that the City wants to get certified by October 13 with the FCC in regard to cable rates.

Moe Kielsmeier questioned when the sewer was going to be cleaned in his area of North Second Street. Commissioner Svoboda advised it would be cleaned.

Commissioner Priller moved to go into Executive Session to discuss employment for the street and water departments. Seconded by Frank Svoboda.
