The Council of the City of Oregon met in regular session
September 14, 1981, Monday at 7 P.M., City Hall Building.

Present: James Barnes, Mayor and Commissioners Robert Aurand, Frank Svoboda, James Ludwig and Norman Collins.

Absent: None.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the August 24, 1981 meeting be approved as recorded. Seconded by Robert Aurand.

Seconded by James Ludwig.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Mayor Barnes moved that Jefferson Street, between 3rd and 5th Streets be closed during Autumn on Parade festivities.
Seconded by Frank Svoboda.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Collins moved: Pursuant to published advertisement for bids for Watermain Extension, said bids having been opened and read at a public hearing held at 1 P.M. August 27, 1981, I move that the bid of Schlichting & Sons Excavating, Inc., Caledonia, in the amount of \$247,289.08 be approved, contingent upon the Mayor and City Clerk being successful in obtaining the \$348,000.00 for the Working Cash Bonds on September 15, 1981.
Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Commissioner Collins moved that the contract with Schlichting & Sons, Inc. for Phases I and II be extended by change order using unit prices stated in the original bid to include Phase III of the City's watermain project at the additional cost of \$82,685.79 subject to further change order and revision, contingent on receipt of proceeds from Working Cash Bond sale. Seconded by Robert Aurand.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.

Jerry Hinricks, Superintendent of Ogle County Highway Department, made a presentation to the council explaining what road construction is needed throughout the county and asking their support on a referendum to increase the county highway tax from 10 to 20%.

Pete Alfano, owner of Alfano's Pizza, addressed the council explaining that he was in Greece when the Public Hearing was held requesting his restaurant location to be included in the liquor license locations. He thought the hearing was to be held at a later date therefore, he requested another Public Hearing to be held on September 28, 1981, which was granted by the council.

Mrs. Weyrauch addressed the council in reference to the recent heavy rain falls and the flooding that occurred on their property. The council advised Mrs. Weyrauch that they are working on a solution to this problem.

The council discussed amending the hook-up fee for water on the new water main connections. Attorney Smith was instructed to draw up an ordinance increasing the rate.

At 9:35 P.M., the council went into executive session to discuss a proposal between the Oregon Park District and the city on the city's property in the southwest section of Oregon.

At 9:58 P.M., regular meeting reconvened.

There being no further business, Commissioner Aurand moved that the meeting be adjourned.

Said motion carried on roll call as follows: Ayes: Aurand, Svoboda, Ludwig, Collins, Barnes. No nays.
