Donna Mann requested some changes in the Autumn on Parade earlier request for city assistance. They would like four parking spaces reserved on 4th Street for shuttle service at Century 21 area, four spaces in the 3rd Street Parking Lot behind the library for residents of Library Court Apartments, since Jefferson Street will be closed and two spaces on 6th Street for two residents parking who live on Jefferson Street where the street is closed off. She also inquired about water service for the rest room facility they would like to get. The Council advised there was no way for the water service to be furnished.
