Engineer's Report

1. Reports the state is not doing Route #64 this year.
2. Mix Street Sewer Line - the agreement with Dave Martin was changed from \$4,500.00 to \$4,000.00 as was originally determined. There will be no waiver for hook up fees when these properties are developed.
3. Franklin Street - Bible College Steps - Estimate of \$1,600.00 to put the steps in. Motor Fuel Tax funds cannot be used for this purpose. Commissioner Ludwig is against the steps being put in on city property. The engineer is to check with Dave Krogh and see if a different location can be used.

Lila Heuerman submitted a letter asking if the city had insurance to cover her doctor bills from an injury which occurred at the open house. A flag which was propped against the building fell and it startled her and she jerked out of the way and hurt her neck. Attorney Smith advised the city cannot legally pay the claim. The injuries were not from city negligence.

Medical Claim

Commissioner Collins requests that School Street between Fifth and Sixth Street be closed off October 4 for Autumn on Parade festivities. Request approved by the Council.

There being no further business. Commissioner Collins moved to adjourn. Seconded by Elma Braden.

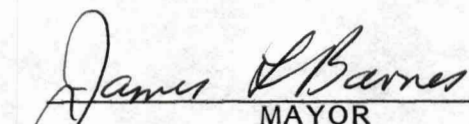
