The Council of the City of Oregon met Monday, September 26, 1983 at 7:00 P.M., City Hall building.

Present: James Barnes, Mayor and Commissioners Norman Collins, Elma Braden, James Ludwig and Frank Svoboda. Absent: None.

Also present: City Attorney David Smith, Chief of Police Robert Jones and City Clerk Julianne Crowley.

Mayor Barnes opened the meeting with the Pledge of Allegiance.

Commissioner Ludwig moved that the minutes of the September 12, 1983 meeting be approved as recorded. Seconded by Commissioner Braden.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Commissioner Collins moved that the payroll in the amount of \$13,068.28 and claims as listed be allowed: Golden Rule Insurance, city's cost group insurance, \$838.92; Garard, Moehle & Smith, city attorney fee for September, \$166.66; Postmaster, postage, \$200.00; Sterling Business Machines, supplies, \$20.00; Republican Reporter, legal publishing, \$5.60; Seri-Graphics, vehicle maintenance material, \$375.00; Callaghan & Company, legal expense, \$91.00; Eby-Brown, police supplies, \$96.46; Shouer's, police supplies, \$2.98; Commonwealth Edison, power, \$4,344.86; I.M.L. Risk Management, deductible to date, \$1,000.00; Oregon Day Care Center, Rev. Sharing Allotment Ent. #14, \$500.00; Brown's Electric Service, electrical work at coliseum out of Rev. Sharing allotment, \$206.98; Spangler Brothers, rest room renovation at coliseum out of Rev. Sharing allotment Ent. #14, \$2,009.66; Citizen State Bank, principal & interest on Working Cash Bonds, \$96,170.00; Dayton Superior Corporation, chemical for refuse containers, \$8.00; J. H. Patterson, street and water department supplies, \$12.11; Della Long, janitor service, \$15.00; W. B. Mayor Barnes moved that Ordinance #879, introduced and filed for public inspection September 12, 1983, an ordinance amending and supplementing the liquor code, be passed. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Commissioner Ludwig moved that McClure Engineering be retained to prepare the 1984 paving program - design, survey and prepare plans - at a cost not to exceed \$9,100.00 per contract memo. Seconded by Norman Collins.

Said motion carried on roll call as follows: Ayes: Collins, Braden, Ludwig, Svoboda, Barnes. No nays.

Dr. Lovelace, Superintendent of Schools, and Mayor Barnes publicly commended Bernice Hitchcock for her alertness as a school crossing guard in averting a tragedy while assisting children across the highway. Mayor Barnes presented Mrs. Hitchcock with a plaque in appreciation of her heroic action.

Mayor Barnes proclaimed October 16-23, 1983 as National Lupus Week.

The Clerk presented a liquor application submitted by Linda Johnson, filed September 21, 1983, for the Ganymede Restaurant, located at 412 Washington Street. She is planning to lease the establishment from JAM, Inc., effective November 1, 1983.

Commissioner Ludwig requests that the Department of Transportation be contacted and inquire if a flashing amber light could be erected east of Tenth Street on Route #64, warning motorists of the school crossing area.

Dr. Lovelace requested the curb be cut back 280 feet west of Tenth Street on the south side. The Council denied the request.

Commissioner Ludwig advised the Council that four "No Parking During School Hours" signs will be erected on Madison Street between Ninth and Tenth Streets.

Dennis McMullen, representative of McClure Engineering, gave a report on the First Street Water Main Extension from Jefferson Street to the north side of Washington Street, the estimated cost \$6,500.00. By extending the main to the north side of Washington Street, property purchased by the

fire department from Charles Mongan will have access to hook onto the main.
The Council approved the project and will proceed with it.

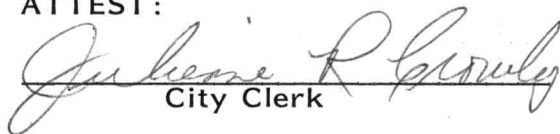
There being no further business, Commissioner Collins moved
