Commissioner Aurand reports that he met with the Library Board in regard to moving the Taft sculptures which are at Mix Park. The two boards agree that two members of each board should meet and discuss any problems and details. Mayor Barnes appointed Commissioners Collins and Aurand to meet with Board Members Mike Ryder and John Carpenter. The Clerk was instructed to arrange the date and time.

Linda Lovvorn and Dorothy Helle addressed the Council with their problem of the basement wall collapsing at the residence at Sixth and Franklin. After discussion, Dennis McMullen was instructed to contact the Schlichting Construction Co. and set a time to review the damage.
