Attorney Wendy Howarter discussed the liquor licenses Ordinance. The City has received two applications and there are no licenses available at this time so the Council is making two more Class D license. Commissioner Tom Stone moved to pass Ordinance#1135 adding two more Class D licenses, Seconded by Commissioner Gerald Medlar.

The Council discussed the NICOR Ordinance. Mayor Mike Arians moved that the NICOR Ordinance be passed will the length of the contract being forty years and that the City be able to get out of it at any time during this period, Seconded by Commissioner Gerald Medlar.

Attorney Wendy Howarter discussed the recommendation from the Plan Commission regarding Century Hills subdivision. A letter was sent out to the owners regarding the weeds and the retention pond in the subdivision and they have not done any of these things. The Plan Commission recommends that the Council put a time limit on when things need to be done. Commissioner Amy Trimble moved that if the work is not completed by October first that the Council makes a motion at the October 12, 1999 meeting to put a restriction on building permits issued, Seconded by Commissioner Tom Stone.

Roll Call: Medlar, Stone, Trimble, Arians. No Nays.

Chief Tom Miller explained the vandalism that took place at a home in the City for the second time. The owner is not keeping the property up and he is afraid of the safety for the other property owners in the area. The Council discussed a section is the National Property Maintenance Building Code that would help with this situation. Mayor Mike Arains moved to pass Ordinance#1136 Emergency Measures so that Chief Miller can post at the entrance of the property a notice that reads as follows: It shall be unlawful for any person to enter this structure except for the purpose of securing the structure, making the required repairs, removing the hazardous condition or demolishing, Seconded by Commissioner Gerald Medlar.

The Mayor read the letter from IDOT regarding the crosswalk at Route Two and Fifth Street. They requested that the City conduct a manual pedestrian count at that intersection before that can justify putting a warning device.

Wendy Howarter handed out the criminal prosecutions that she had taken care of in the last month and a hand out for Offenses Against Public Morals for the Council to review.
