Oregon Township has requested to rezone two lots that they have purchased from R-1 zoning to Commercial zoning. No one in the audience was opposed to the rezoning. Rick McCanse moved to recommend to the City Council the zoning change from R-1 to Commercial submitted by Oregon Township for lots 18 and 19 in Strauee Water Power Addition, Seconded Stan Olson.

Candy Morris spoke on behalf of Chris & Jessica Throw they would like to divide 801 S 2<sup>nd</sup> Street into two tracts and request driveway access off of 1<sup>st</sup> Street. Two joining property owners Donna Countryman and Nancy Deneau questioned the driveway access off of 1<sup>st</sup> Street. They both feel it's a safety issue. Wendy read the section out of the city codebook pertaining to driveway permits. The street superintendent would have to ok the driveway permit at the time it's applied for so the issue of the driveway access will have to wait until the permit is applied for. The two residents would like to be notified when the permit is applied for. The City Clerk will forward this to Mike Bowers the Street Superintendent. Rick McCanse moved to recommend to the City Council resubdividing the property located at 801 S 2<sup>nd</sup> Street owned by Chris and Jessica Throw into two parcels, Seconded by Larry Wright.

Dan Roos has requested to rezone 104 S 9<sup>th</sup> Street from R-1 zoning to Commercial zoning. A letter was received from Rosemary Eike representing the Oregon Church of Nazarene. They had concerns regarding the parking, littering, noise, and possibly the sale of alcohol. Wendy read the section in the city codebook pertaining to alcohol. No alcohol can be sold 100 feet from a Church. Rick McCanse moved to recommend to the City Council the rezoning of the property located at 104 S 9<sup>th</sup> Street from R-1 to Commercial submitted by Nancy & Dan Roos, Seconded by Thomas Izer.
