

Planning Commission Meeting

The Planning Commission of the City of Oregon met Tuesday June 21, 2011, 6:00 P.M. in the City Hall Council Chambers.

Amy Trimble called the meeting to order.

A Public Hearing took place for a variance submitted by Jim Tegtmeyer to construct an enclosed metal carport on the rear lot line and a three foot setback on the side lot line. No one spoke against the variance. The Public Hearing was closed.

Mike Bowers said that he could live with a three foot set back to the rear, but not on the lot line so there's room to pile snow. Jerry Hinrichs said when he constructed his new garage he had to follow the current setbacks and glad he did because of the traffic in the alley.

Amy read the seven standard questions when a variance is submitted.

Rich Rhoads made a motion to recommend to the City Council that the variance submitted by Jim Tegtmeyer to build a metal carport on the rear lot line and three feet from the side be denied and that he follow the current set backs in place, Seconded by Jerry Hinrichs.

Ayes: Rhoads, Miller, Bowers, and Hinrichs. Nays: Trimble.

Rich Rhoads moved to approve the May 17, 2011 minutes, Seconded by Jerry Hinrichs.

Motion carried. No Nays.

Clay Lindsay, Attorney for City of Byron, was present to discuss the proposed Intergovernmental Agreement between the City of Byron and the City of Oregon. Although there is no current development being planned in the unincorporated areas between the two cities, they fell it's a good idea to have an agreement in effect prior to the time we reach such an issue. It was asked how the boundary was determined. Clay said they used the Forest Preserve property as the boundary. The committee would like to have a bigger map to discuss the boundary line at the next meeting.

Amy would like to update the ordinance for new commercial buildings. She asked Charlene if she could check with other communities to see if they have anything in place.

Amy Trimble moved to adjourn the meeting, Seconded by Mike Bowers.






